

REGULATIONS FOR PAID, UNATTENDED, PUBLIC PARKING

1. By entering the parking area located in Sztutowo at Muzealna Street 6, the user, hereinafter referred to as the Tenant, agrees to comply with the conditions specified in these Regulations.
2. The parking is paid, unattended, and the owner of the parking lot, the Stutthof Museum in Sztutowo, hereinafter referred to as the Museum, shall not be liable for vehicles or property left on its premises.
3. The parking fee schedule is an annex to these Regulations.

I. GENERAL PROVISIONS

1. In the case of a single rental, the rental of a parking space begins upon entering the parking area and ends upon exiting the parking lot. Proof of rental is the parking ticket obtained from the entry machine.
2. The parking ticket entitles the holder to rent a space only within the parking area for which it was issued.
3. The ticket will not be issued by the entry machine in the event of a lack of available parking spaces designated for single rentals.
4. The parking is paid every day of the week and is open:
 1. From May 1 to September 30 from 8:00 AM to 5:00 PM;
 2. From October 1 to April 30 from 7:00 AM to 3:00 PM.
5. The price list and Regulations are available for inspection at the Museum's office. Additionally, the price list is posted before entering the parking area, and the Regulations are available at the parking cash register.
6. In the event of a parking system malfunction, please contact the Museum Guard personnel.

II. CONDITIONS OF USE OF THE PARKING LOT, PARKING CONTROL

1. The provisions of the Traffic Code apply within the parking area.
2. The Tenant is obliged to comply with these Regulations and the instructions issued by the staff.

3. The Museum Guard personnel are responsible for monitoring compliance with these Regulations regarding the parking of vehicles.
4. The Tenant is required to park the vehicle only in designated parking spaces.
5. The Museum does not supervise or protect the property left by Tenants in the parking area. All actions taken by the service staff are for order maintenance and are conducted to ensure the proper execution of the rental agreement by the Tenant and the Museum.
6. The amount of fees for renting a parking space is specified in the price list, which is an annex to these Regulations. The prices listed in the annex are gross prices.
7. A lost parking ticket will incur a fee of 100 PLN (one hundred zlotys) gross.
8. After paying for the ticket, the Tenant has 10 minutes to exit the parking area.

III. OWNER'S LIABILITY

1. The Museum is only liable for damages caused by its employees or contractors during the rental period.
2. The Museum is not liable for the loss or damage to property left by the Tenant in the parking area, except as stated in paragraph 1.
3. The Tenant is required to immediately report any damage for which the Museum may be liable, as mentioned in point 1, no later than before leaving the parking area, under the penalty of losing the claim.
4. The Museum is not liable for damages caused by other Tenants or third parties.

IV. TENANT'S LIABILITY

1. The Tenant is responsible for all damages caused by themselves or accompanying individuals to parking infrastructure and third parties.
2. The Tenant is liable for damages caused by transferring the parking ticket to a third party.

V. SAFETY REGULATIONS

1. The maximum speed limit in the parking area is 10 km/h.
2. It is strictly prohibited in the parking area to:

1. store fuels, flammable substances, and empty fuel containers.
 2. refuel vehicles.
 3. park vehicles with leaking fuel systems.
3. It is prohibited to repair, wash, vacuum vehicles, or change cooling fluids, fuels, or oils on parking spaces and internal roads, as well as polluting the parking area.
 4. If a member of the Museum Guard finds that the Tenant does not comply with these Regulations, particularly the provisions from paragraphs 1 to 3, they will be called upon to immediately cease violations. If they fail to comply with the instructions, they may be required to leave the parking lot. In this case, the fee paid for the parking ticket is non-refundable.
