## Order No. 31/2017

Director of the Stutthof Museum in Sztutowo Dated November 24, 2017

Regarding the introduction of the Visitor Regulations for the Stutthof Museum in Sztutowo:

Pursuant to §12, section 2, point 7 of the Statute of the Stutthof Museum in Sztutowo, attached to the Ordinance of the Minister of Culture and National Heritage dated December 16, 2015, on the granting of the Statute of the Stutthof Museum in Sztutowo (Official Journal of the Ministry of Culture and National Heritage, item 59), in connection with Article 2, point 9 of the Act of November 21, 1996, on museums (consolidated text of 2017, item 972, as amended), I hereby order as follows:

**§1** 

I introduce the Visitor Regulations for the Stutthof Museum in Sztutowo, attached to this Order.

**§2** 

I hereby repeal Order No. 12/2010 of the Director of the Stutthof Museum in Sztutowo on the Visitor Regulations for the Stutthof Museum in Sztutowo, dated October 12, 2010.

**§3** 

This Order comes into effect on the date of signing.

## Visitor Regulations at the Stutthof Museum in Sztutowo

- 1. Admission to the Museum is free of charge.
- 2. The Museum exhibitions are open daily:
  - o From May 1 to September 30: 8 AM 6 PM
  - o From October 1 to April 30: 8 AM − 3 PM
- 3. The Director may temporarily change the opening hours, rules of visitation, and designate holidays when the Museum is closed. Detailed information about changes is posted on the website: <a href="https://www.stutthof.org">www.stutthof.org</a>.
- 4. The last entry to the Museum is allowed half an hour before closing.
- 5. Entry to the Museum after closing hours is prohibited.
- 6. Visitors must follow the instructions of the Visitor Services Office staff, Museum Security guards, guides, and other Museum employees when intervention is deemed necessary.

- 7. The Museum may be visited individually or in organized groups, accompanied by a guide.
- 8. The Visitor Services Office is responsible for organizing services for both group and individual visitors.
- 9. Visiting the Museum is allowed only along the designated route.
- 10. The grounds and buildings of the former Stutthof camp may be visited independently by individuals aged 13 and above. Children under 13 must be accompanied by adults.
- 11. The following are prohibited on Museum grounds:
- Entry by individuals under the influence of alcohol or psychoactive substances, as well as bringing and consuming alcohol.
- Smoking tobacco products, electronic cigarettes, and using open flames.
- Bringing bicycles or driving vehicles beyond the designated parking area.
- Loud behavior.
- Using mobile phones indoors or in a way that disturbs other visitors.
- Using radios or music players, except with headphones.
- Bringing strollers into buildings and barracks (this does not apply to wheelchair users).
- Bringing dogs or other animals (except guide dogs for persons with disabilities).
- Bringing large bags, especially into the exhibition spaces.
- Bringing and consuming food.
- Touching, moving, removing, or damaging any objects or items on Museum grounds.
- Entry by individuals in beachwear or those inadequately or provocatively dressed.
- Using drones on Museum grounds without the Director's permission.
- Bringing and using trekking poles on Museum grounds.
- Taking photographs indoors using a flash.
- 12. Taking photographs and audiovisual recordings of the Museum's grounds, buildings, and exhibitions for personal use is free of charge and does not require the Director's permission.
- 13. Photographic and audiovisual works featuring the Museum's grounds, buildings, and exhibitions may not be disseminated or published, including for commercial or promotional purposes, without the Director's consent.
- 14. Visitors must not hinder the experience of other individuals or groups with their behavior.
- 15. Entry to the Museum signifies acceptance of these Regulations by the visitor.
